#### ORDINANCE NO. 2361

#### ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF WINNECONNE

WHEREAS, a petition for direct annexation by unanimous consent (hereinafter the "Petition") of the following territory in the Town of Winneconne, Winnebago County, Wisconsin, to the Village of Winneconne was filed with the Village Clerk on April 20, 2023 to include the property legally described below and shown on the scale map, attached hereto as **Exhibit A.** 

LAND THAT IS PART OF GOVERNMENT LOT 2, SECTION 16, TOWNSHIP 19 NORTH, RANGE 15 EAST, IN THE TOWN OF WINNECONNE, WINNEBAGO COUNTY, WISCONSIN MORE FULLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF SECTION 16, TOWNSHIP 19 NORTH, RANGE 15 EAST; THENCE ALONG THE WEST LINE OF THE SOUTHWEST 1/4 OF SAID SECTION 16, NORTH 00 DEGREES 06 MINUTES 25 SECONDS EAST, 2201.05 FEET TO THE SOUTHWEST CORNER OF BLOCK 23, "PLAT OF SCOTT'S ADDITION"; THENCE CONTINUING ALONG SAID WEST LINE ALSO BEING THE ASSUMED WEST LINE OF BLOCK 23, "PLAT OF SCOTT'S ADDITION", NORTH 00 DEGREES 06 MINUTES 25 SECONDS EAST, 120.00 FEET TO THE POINT OF BEGINNING; THENCE EAST ALONG THE NORTH LINE OF SAID BLOCK 23, SOUTH 87 DEGREES 31 MINUTES 32 SECONDS EAST, 162.89 FEET; THENCE ALONG THE EXTENDED WEST LINE OF LOT 9 OF SAID BLOCK 23 TO THE NORTH, NORTH 00 DEGREES 56 MINUTES 18 SECONDS EAST, TO THE CHANNEL; THENCE WEST ALONG THE CHANNEL TO THE WEST SECTION LINE OF THE SOUTHWEST 1/4 OF SECTION 16; THENCE FROM WHERE THE CHANNEL MEETS THE WEST LINE OF THE SOUTHWEST 1/4 OF SECTION 16 SOUTH BACK TO THE POINT OF BEGINNING, INCLUDING ALL LAND NORTH OF THE NORTH LINE OF LOTS 10 AND 11 OF BLOCK 23, "PLAT OF SCOTT'S ADDITION" TO THE CHANNEL CONTAINING ± 1,580 SQUARE FEET.

WHEREAS, the Village Clerk has investigated the Petition and has advised that the Petition complies with Wis. Stat. § 66.0217(2), in that all of the owners of real property in such territory have signed the petition; that there are zero (0) electors residing in the territory; that such Petition was properly filed with the Village Clerk together with a scale map and a legal description of the property showing the boundaries of the property to be annexed and its relationship to the Village, and that copies were timely filed with the Town Clerk of the Town of Winneconne; and that copies were mailed to the Wisconsin Department of Administration; and

WHEREAS, prior to its action on this Ordinance, the Village Board has reviewed the advice of the Department of Administration (MBR number 14589) finding that the annexation is in the public interest.

**NOW, THEREFORE**, the Board of Trustees for the Village of Winneconne does ordain as follows:

- Section 1. <u>Adequacy of Petition</u>. That the Petition was signed by all the owners of all of the real property in the territory and that there are zero (0) electors residing in the territory; and therefore, it is a sufficient and legal petition conforming to the requirements of Wis. Stat. § 66.0217(2).
- Section 2. Annexation of Territory. The territory described is hereby annexed to the Village of Winneconne and shall be included in the Village's official zoning map and is temporarily designated as R-1B Residential pursuant to Village Code Section 580-18. The Village Clerk is hereby instructed to file immediately with the Secretary of Administration a certified copy of the Ordinance, certificate and plat, and shall send one copy to each company that provides any utility service in the area that is annexed. The Village Clerk shall also file with the County Clerk the report required by Wis. Stat. § 5.15(4)(bg). The Village Clerk shall also record the Ordinance with the Winnebago County Register of Deeds and file a signed copy of the Ordinance with the Clerk of the Winneconne School District all in accordance with Wis. Stat. § 66.0217.
- Section 3. <u>Election Ward</u>. The territory described is hereby made a part of Election Ward 2 of the Village of Winneconne.
  - Section 4. **Population**. The current population of the annexed territory is zero (0).
- Section 5. Agreement to Pay Property Taxes. Pursuant to Wis. Stat. § 66.0217(4), the Village of Winneconne does hereby agree to pay annually to the Town of Winneconne, for five (5) years, an amount equal to the property taxes that the Town of Winneconne levied on the herein described annexed territory, as shown by the Tax Roll under Wis. Stat. § 70.65, in the year in which the annexation is final.
- Section 6. <u>Effective Date</u>. All ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict, and this Ordinance shall be in effect from and after its passage.




