ORDINANCE NO, 2024-04-15

AN ORDINANCE ANNEXING PROPERTY OWNED BY THE LARRY E. JEIDY AND CAROL E. JEIDY IRREVOCABLE TRUST DATED DECEMBER 28, 2010, LOCATED IN THE TOWN OF FENNIMORE, GRANT COUNTY, WISCONSIN.

The City of Fennimore purchased certain real estate in the Town of Fennimore and now annexes it to the City of Fennimore.

The Fennimore City Council, Grant County, Wisconsin, does now ordain as follows:

<u>Section I</u>: Pursuant to Wisconsin Statute §66.0217(2), the following described real estate (the Territory) which is owned by THE LARRY E. JEIDY AND CAROL E. JEIDY IRREVOCABLE TRUST DATED DECEMBER 28, 2010, is now detached from the Town of Fennimore, Grant County, Wisconsin, and it is annexed to the City of Fennimore, Grant County, Wisconsin. A scale map of the territory is attached as Exhibit A and incorporated into this Ordinance.

Section II: Territory Annexed. The territory being annexed is generally described as the Southwest Quarter (SW 1/4), and the South Half (S 1/2) of the Northwest Quarter (NW 1/4) of Section Twenty-one (21), Town Six (6) North, Range Two (2) West, Town of Fennimore, Grant County, Wisconsin.

The complete legal description of the property being annexed is attached as Addendum A and incorporated into this Ordinance in full.

Grant County Tax Parcels: 016-00461-0000, 016-00462-0000, 016-00463-0000, 016-00466-0000, 016-00464-0000, and 016-00465-0000.

Total Acres: approximately 240 acres

Municipal Boundary Review file number: 14652

Section III: From and after the attachment of the Territory to the City, it shall be part of the City for all purposes provided by law, and all persons coming into such Territory shall be subject to all laws, ordinances, resolutions, rules and regulations of the City of Fennimore.

Section IV: The territory annexed is contiguous to the City of Fennimore.

Section V: The territory annexed is vacant land and has a current population of zero. The territory will be part of the City of Fennimore Ward 3 voting district.

Section VI: The Territory annexed shall be made part of the Industrial District under the City's Zoning Ordinance as a temporary zoning classification in the City of Fennimore.

Section VII: This Ordinance shall take effect upon adoption and publication, and upon the filing of seven certified copies of this Ordinance and the attached Exhibit and Addendum with the Department of Administration.

<u>Section VIII</u>: The City Clerk is directed to file seven certified copies of this Ordinance and the attached Exhibit and Addendum showing the boundaries of the Territory annexed and attached to the City with the Secretary of the Department of Administration, 101 E. Wilson Street, 10th Floor, P. O. Box 7864, Madison, WI 53707.

Section IX: If any provision of this Ordinance is declared invalid by any court with jurisdiction to so rule, or the application of this Ordinance to any person or circumstance is ruled invalid by any court with jurisdiction to so rule, that invalidity shall not affect the other provisions of this Ordinance which may be given effect without the invalid provision or application.


