#### **ORDINANCE 0318-24-02**

The City of New Lisbon, Juneau County, Wisconsin, does hereby ordain:

#### **SECTION I: PURPOSE**

The purpose of this ordinance is to annex property pursuant to Wisconsin Statute §66.0217. The ordinance is also designed to permanently designate a zoning classification and to amend the zoning map pursuant to Chapter 520 of the New Lisbon Code pertaining to Amendments.

# SECTION II: PROVISION AMENDED

The zoning map for the City of New Lisbon as set forth in the official map provided for in the Ordinances for the City of New Lisbon is hereby permanently amended so as to zone the territory listed below in the manner set forth below.

#### SECTION III: PROPERTY ANNEXED

In accordance with Wisconsin Statutes s.66.0217(3)(a), and the petition for annexation filed with the City Clerk; the following, signed by the owners of at least ½ of the land in area in the territory in the Town of Lisbon, Juneau County, Wisconsin, is annexed to the City of New Lisbon, Wisconsin:

Commencing at the east ¼ corner of Section 9, Town 16 North, Range 3 East, which is the point of beginning; thence S89°58′54″W, along the south line of the SE ¼ of the NE ¼ of Section 9, 1326.40 feet to the southwest corner of the SE ¼ of the NE ¼ of Section 9; thence S00°55′35″E, 21.75 feet to the southeasterly corner of Parcel 2 of CSM 1347; thence S74°31′50″W, 265.28 feet; thence S71°54′45″W, 334.95 feet; thence S82°32′00″, 437.32 feet; thence S67°38′05″W, 337.12 feet to the southwesterlyOR corner of Parcel 2 of CSM 1347; thence N01°04′55″W along the west line of Parcel 2 of CSM 1347, 710.01 feet to a point in the centerline of Germantown Road; thence N60°20′55″E along the centerline of Germantown Road, 835.38 feet; thence S61°24′35″E, 137.17 feet; thence N80°10′05″E, 480.91 feet; thence N00°55′35″W, 317.20 feet to a point in the centerline of Germantown Road; thence N58°56′23″E along said centerline, 979.11 feet to a point on the east line of the SE ¼ of Section 9; thence S00°46′25″E along the east line of the SE ¼ of Section 9, 1825.50 feet to the point of beginning.

Said parcel contains 2,983,450 square feet or 68.49 acres, more or less.

All lands are located in part of the following quarter-quarter sections:

SW ¼, NE ¼, Section 9, T16N, R03E NW ¼, SE ¼, Section 9, T16N, R03E NE ¼, NE ¼, Section 9, T16N, R03E SE ¼, NE ¼, Section 9, T16N, R03E

## SECTION IV: EFFECT OF ANNEXATION

From and after the date of this ordinance the territory described in section III shall be a part of the City of New Lisbon for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of New Lisbon.

## **SECTION V: ZONING**

The property described above is hereby zoning I-2 Industrial/Commercial/Special District.

## SECTION VI: WARD DESIGNATION

The territory describe above of this ordinance is hereby made part of the six (6) ward of the City of New Lisbon, subject to the ordinances, rules and regulations of the City of New Lisbon governing wards.

## SECTION VII: CONFLICTING PROVISIONS REPEALED

If any section, sentence, clause, phrase, or application of this ordinance is held to be invalid or unconstitutional for any reason, such decision shall not affect the validity of the remaining sections, sentences, clauses, phrases, or applications of this ordinance, which shall remain in effect. It is the legislative intent that this ordinance shall remain in effect notwithstanding the invalidity of any part or application of this ordinance.

## SECTION VIII: EFFECTIVE DATE

This ordinance shall take effect upon passage and publication as provided by law.


