ORDINANCE NO. 1022 ORDINANCE OF DIRECT ANNEXATION BY UNANIMOUS APPROVAL (Jay Ambe, LLC)

THE COMMON COUNCIL OF THE CITY OF SPARTA, MONROE COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section 1. Pursuant to Section 66.0217(2), Wis. 
