The undersigned property owner(s), owning one hundred percent (100%) in area of the lands hereinafter described, and there being zero (0) resident elector(s) in said area, and said undersigned being also the owner(s) of one hundred percent (100%) of the real property and assessed valuation in said area in the following territory of the Town of Union lying contiguous to the City of Eau Claire, petition the Honorable Council of the City of Eau Claire to annex the territory described below and shown on the attached scale map to the City of Eau Claire, Eau Claire County, Wisconsin.

A parcel of land located in the NE ¼ of the NE ¼ of Section 10, T27N, R10W, City of Eau Claire, Eau Claire County, Wisconsin, more fully described as follows:

Commencing at the NE corner of said Section 10; thence S00°23'20"W (recorded as S01°17'20"W) along the east line of the NE ¼, 177.71 feet; thence N75°05'44"W 51.65 feet to the point of beginning; thence S00°23'20"W (recorded as S01°17'20"W) 99.11 feet; thence N89°27'46"W 148.00 feet along the south line of the parcel recorded in Volume 563, Page 614 to the southwest corner thereof; thence N00°23'20"E along the west line of said parcel 137.05 feet to a point on the southerly 1 in e of STH 124 right of way; thence S75°05'44"E (recorded as S74°13'50"E) along said line 152.88 feet to the point of beginning.

The parcel contains 0.40 acres or 17,476 square feet, more or less, and is subject to easements of record.

Notes:

The lots in this land division may experience noise levels exceeding the levels in s. Trans 405.04, Table 1. These levels are based on federal standards. The Department of Transportation is not responsible for abating noise from existing state trunk highways or connecting highways, in the absence of any increase by the department to the highways through-lane capacity.

No new improvements or structures are allowed between the right of way line and the highway setback line. Improvements and structures include, but are not limited to signs, parking areas, driveways, wells, septic systems, drainage facilities, buildings and retaining walls. It is expressly intended that this restriction is for the benefit of the public as provided in section 236.293, Wisconsin Statutes, and shall be enforceable by the Wisconsin Department of Transportation or its assigns. Contact the Wisconsin Department of Transportation for more information. The phone number may be obtained by contacting the County Highway Department.


All lots and blocks are hereby restricted so that no owner, possessor, user, licensee or other person may have any right of direct vehicular ingress from or egress to any highway lying within the right of way of STH 124 and CTH "TT"; it is expressly intended that this restriction constitutes a restriction for the benefit of the public as provided in s. 236.293, Stats., and shall be enforceable by the department or its assigns. Any access shall be allowed only by special exception. Any access allowed by special exception shall be confirmed and granted only through the driveway permitting process and all permits are revocable.



Subject: MOGENSEN ANNEXATION

Section 66.0217 (6), Wis. Stats., provides that the annexation of lands to cities and villages within a county having a population of 50,000 or more shall be reviewed by the Department of Administration in order to determine if the proposed annexation is in the public interest or against the public interest. The proposed annexation from the TOWN OF UNION to the CITY OF EAU CLAIRE (see attached description) must be reviewed pursuant to the statute.







Subject: MOGENSEN ANNEXATION

The proposed annexation submitted to our office on June 12, 2018, has been reviewed and found to be in the public interest. In determining whether an annexation is in the public interest, s. 66.0217 (6), Wis. Stats. requires the Department to examine "[t]he shape of the proposed annexation and the homogeneity of the territory with the annexing village or city..." so as, to ensure the resulting boundaries are rational and compact. The statute also requires the Department to consider whether the annexing city or village can provide needed municipal services to the territory. The subject petition is for territory that is reasonably shaped and contiguous to the CITY OF EAU CLAIRE, which is able to provide needed municipal services.

Note: The subject parcel should be identified as being located in the Town of Union in the parcel description.

The Department reminds clerks of annexing municipalities of the requirements of s. 66.0217 (9)(a), Wis. Stats., which states:

"The clerk of a city or village which has annexed shall file immediately with the secretary of administration a certified copy of the ordinance, certificate and plat, and shall send one copy to each company that provides any utility service in the area that is annexed. The clerk shall record the ordinance with the register of deeds and file a signed copy of the ordinance with the clerk of any affected school district..."
