Subject: CEDAR LODGE & SETTLEMENT OWNERS ASSOCIATION ANNEXATION

The proposed annexation submitted to our office on August 24, 2022, has been reviewed and found to be in the public interest. In determining whether an annexation is in the public interest, s. 66.0217 (6), Wis. Stats. requires the Department to examine "[t]he shape of the proposed annexation and the homogeneity of the territory with the annexing village or city...." so as, to ensure the resulting boundaries are rational and compact. The statute also requires the Department to consider whether the annexing city or village can provide needed municipal services to the territory. The subject petition is for territory that is reasonably shaped and contiguous to the Village of Lake Delton, which is able to provide needed municipal services.

Notes: The scale map and legal description do not currently meet the requirements in s. 66.0217(1), Wis. Stats. The map does not show and identify the boundary of the territory being annexed or the existing municipal boundary. It appears that petitioners intend to annex all of CSM Lots 1, 3, and 4. If this is in fact the case then the legal description can simply be these lot numbers plus the CSM number and section, town, and range. However, if parts of these Lots are not included, or if additional territory beyond the Lots is included, then a metes and bounds description of the entire annexation territory will be required, commencing from a section corner.

The clerk of a city or village which has annexed shall file immediately with the secretary of administration a certified copy of the ordinance, certificate and plat, and shall send one copy to each company that provides any utility service in the area that is annexed. The clerk shall record the ordinance with the register of deeds and file a signed copy of the ordinance with the clerk of any affected school district. Please file a copy of your annexing ordinance, including a statement certifying the population of the annexed territory. **Please include your MBR number 14526 with your ordinance.** Ordinance filing checklist available at http://mds.wi.gov/, click on "Help on How to Submit Municipal Records".
