4	INTRODUCED BY: Executive Committee	
5	To the Henevelle Pound of Sun amiseur of Columbia County	
6 7	To the Honorable Board of Supervisors of Columbia County:	
8	WHEREAS, in 2021 the Columbia County Board of Supervisors adopted a 10-year	
9	supervisory district plan creating county supervisory districts following the 2020 Census; and	
10	WHEREAS, Wisconsin Statutes § 59.10(3)(c) allows a county board, in its discretion, to	
11	alter the boundaries of supervisory districts based on annexations which occur after the adoption	
12	of the 10-year supervisory district plan, as long as the number of supervisory districts is not	
13	changed; and	
14	WHEREAS, the Village of Fall River completed an annexation effective August 9, 2023	
15	of a parcel of land from the Town of Fountain Prairie; and	
16	WHEREAS, the description of the parcel of land and a map of the annexed parcel	
17	(Exhibit A), and a copy of the annexation Ordinance No. 13-1-27(G)(1)-(23 0712) are attached;

19	WHEREAS, the parcel annexed by the Village of Fall River is part of County Supervisor	
20	District 10, consisting of Ward 2, in the Town of Fountain Prairie; and	
21	WHEREAS, it is appropriate to move the annexed parcel into County Supervisor District	
22	19 in Ward 2, Village of Fall River; and	
23	WHEREAS, the population of the annexed parcel is zero; and	
24	WHEREAS, this resolution does not change the number of supervisory districts.	
25	NOW, THEREFORE, BE IT RESOLVED, by the Columbia County Board of	
26	Supervisors that the supervisory district boundaries are hereby altered by moving the annexed

### AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF FALL RIVER, **COLUMBIA COUNTY, WISCONSIN** 13-1-27(G)(1)-(23 0712)

The Village Board of the Village of Fall River, Wisconsin do ordain as follows:

SECTION 1. Territory Annexed. In accordance with sec. 66.0217(2) of the Wisconsin Statutes and the petition for direct annexation filed with the Village Clerk on the 16<sup>TH</sup> day of May, 2023: signed by the owners of the land in the area in the territory to be annexed and being the owners of the real property in the territory to be annexed, and whereas the current population of the territory is zero (0), the following described territory in the Town of Fountain Prairie, Columbia County, Wisconsin, is annexed to the Village of Fall River, Wisconsin:

#### See attached legal description and survey map

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be a part of the Village of Fall River for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Fall River.

SECTION 3. Zoning Classification. In accordance with the Comprehensive Plan, adopted August 2009, the territory annexed to the Village of Fall River by this Ordinance is zoned as follows, pursuant to sec 66.0217(8)(a) of the Wisconsin Statutes:

#### I-1 Industrial District

SECTION 4. Ward Designation. The territory described in Section 1 of this Ordinance is hereby made a part of Ward 2 of the Village of Fall River, subject to the ordinances, rules and regulations of the Village of Fall River governing wards.

SECTION 5. Severability. If any provision of the ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 6. Provision. The Village of Fall River requires as a condition of this annexation ordinance that the petitioner agree to pay to the Village of Fall River what the village is required to pay to the township under Sections 66.0217(14) of the Wisconsin Statutes. The petitioner understands that the law prohibits the village from annexing property unless the annexing municipality agrees to pay annually to the town, for five years, an amount equal to the amount of property taxes that the town levied on the annexed territory, as shown by the tax roll, in the year in which the annexation is final,

SECTION 7. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.


