INTENT & SYNOPSIS: To amend the County Supervisory District Map for Districts 14 & 15 to reflect annexation by the City of Wisconsin Rapids

FISCAL NOTE: None

WHEREAS, the Wood County Board of Supervisors adopted the current Supervisory District Boundaries in November of 2021, via Resolution 21-11-4, and,

WHEREAS, the City of Wisconsin Rapids annexed a portion of the Town of Grand Rapids for the construction of a dog park in 2023, and,

WHEREAS, the City has requested that the County amend the boundaries of Supervisory Districts 14 & 15 to move the annexed parcel from Supervisory District 15, representing the Town of Grand Rapids, to Supervisory District 14, representing the City of Wisconsin Rapids, and,

WHEREAS, there is no population in the annexed parcel, and,

WHEREAS, if not approved, a new voting ward would have to be created and ballots printed for a ward that has zero population.

NOW THEREFORE BE IT RESOLVED, the Wood County

Board of Supervisors hereby amends the Supervisory District Maps to transfer the following real property from Supervisory District 15 to Supervisory District 14:

ALL THAT PART OF THE SOUTHWEST 1/4 OF THE NORTHEAST 1/4 OF SECTION 16, TOWN 22 NORTH, RANGE 6 EAST, IN WOOD COUNTY, WISCONSIN, BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF SECTION 16 THENCE RUNNING S 0°15'18" W ALONG THE WEST LINE OF SAID SECTION 1318.17 FEET TO A POINT, THENCE N 89°58'46" E, 1315.11 FEET
