Resolution No. 25 (2019) RESOLUTION APPROVING ALTERATION OF SUPERVISORY DISTRICT BOUNDARY - CITY OF NEW RICHMOND (STATE OF WISCONSIN - VACANT LAND)

WHEREAS, in 2011 the St. Croix County Board of Supervisors adopted a 10-year 1 2 supervisory district plan creating county supervisory districts, municipal aldermanic 3 districts and election wards following the 2010 Census; and 4 5 WHEREAS, Wisconsin Statutes § 59.10(3)(c) allows a county board, in its 6 discretion, to alter the boundaries of supervisory districts based on annexations which occur after the adoption of the 10-year supervisory district plan, as long as the number 7 of supervisory districts is not changed; and 8 9 10 WHEREAS, the City of New Richmond completed an annexation in April 2019 of 11 a parcel described on the attached ordinance consisting of 2.9 acres; and 12 13 WHEREAS, a map of the annexed parcels, along with a copy of the annexation ordinance has been filed with the St. Croix County Clerk and are attached; and 14 15 16 **WHEREAS**, the parcel annexed by the City of New Richmond is part of County 17 Supervisor District 11, consisting of Ward 5, in the Town of Star Prairie; and 18 19 WHEREAS, it is appropriate to move the annexed parcel into County Supervisor District 12 in Ward 1, City of New Richmond; and 20 21 22 WHEREAS, the parcel annexed by the City of New Richmond and made part of 23 Ward 12 does not cross an assembly district or congressional district line; and 24 WHEREAS, the population of the annexed parcel is zero; and 25 26 **WHEREAS**, this resolution does not change the number of supervisory districts. 27 28 29 NOW, THEREFORE, BE IT RESOLVED by the St. Croix County Board of Supervisors that the supervisory district boundaries are hereby altered by moving the 30 31 annexed parcel of land from County Supervisor District 11 to County Supervisor District 12 consisting of Ward 1 in the City of New Richmond as shown on the attached. 32 33 **BE IT FURTHER RESOLVED** that the St. Croix County Clerk is hereby directed to 34

ORDINANCE #532

AN ORDINANCE ATTACHING TERRITORY TO THE CITY OF NEW RICHMOND, WISCONSIN.

THE COMMON COUNCIL OF THE CITY OF NEW RICHMOND DOES ORDAIN AS FOLLOWS:

Section 1. Territory Attached. The following described territory presently located in the Town of Star Prairie is hereby annexed to the City of New Richmond.

Territory described as follows: PARCEL 038-1138-10-100 SEC 34 T31N R18W PT S 1/2 OF THE NE 1/4 BEING LOT 1 OF CSM 8/2394 City of New Richmond 156 East First Street New Richmond, WI 54017

(2.9 ACRES) EXC THAT PT OF CSM 8/2394 IN SW NE ANNEXED CITY NR #480541 261-1211-10-010 (Owned by WI Building Commission)

Section 2. Effect of Attachment. From and after the date of this ordinance the territory described in Section 1 shall be a part of the City of New Richmond, for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of New Richmond.

Section 3. Zoning Classification. (a) Upon recommendation to the City Council of the City of New Richmond the territory described above, attached to the City of New Richmond by this ordinance is designated as Z3 Multi-Use Corridor District.

Section 4. Ward Designation. The territory described in Section 1 of this ordinance is hereby designated as part of Ward 1, Aldermanic District 1, of the City of New Richmond.

Section 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

Section 6. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.



Approval Action Required

Approval and execution of the attached City of New Richmond's Petition for Attachment.

Strategy

The Department of Administration on behalf of the Department of Corrections - St. Croix Correction Center Annexation, requested State Building Commission (SBC) authority to annex approximately 2.9 acres of vacant land (parcel #038-1138-10-100), into the City of New Richmond from the Town of Star Prairie. This land is owned by the State Building Commission and located at the Department of Corrections' St. Croix Correctional Center. The SBC provided its approval on February 20, 2019.

In accordance with guidance received by the City of New Richmond's City Clerk, the proper document required to request this annexation is a Petition for Attachment versus a Petition for Annexation (pursuant to a boundary agreement between the City of New Richmond and the Town of Star Prairie).

Pursuant to guidance provided by DOA Legal, the attached Petition for Attachment can be signed by the Secretary of the State Building Commission.
