**WHEREAS**, based on federal and state laws, municipalities are required to recreate voting districts based on current census figures and compiled each decade; and

**WHEREAS**, Barron County completed this process by Resolutions 2011-15 and 2011-31, and further amended the supervisory districts by Resolutions 2013-41, 2013-42, 2014-45, 2018-25, 2019-3, 2019-21, 2020-4, 2020-5 and 2020-23; and

**WHEREAS**, Section 59.10(3)(c), Wis. Stats., provides that: “1.After the enactment of a plan of supervisory districts under par. (b), the board may amend the plan to reflect a municipal incorporation, annexation, detachment or consolidation. The number of supervisory districts in the County shall not be changed by any action under this subdivision.”; and

**WHEREAS**, the City of Rice Lake has annexed two parcels of property from the Town of Rice Lake as identified in the attached map, ordinance annexing, and further described as:

Parcel ID #038-0800-23-010 (now 276-8001-01-400) and 038-0800-29-000 (now 276-8001-01-475)

The Northeast Quarter of the Southwest Quarter and the Southeast Quarter of the Southwest Quarter, of Section 8, Township 35 North, Range 11 West, Barron County, Wisconsin, EXCEPT:

- a) That part conveyed for highway use per Volume 395, Page 472;
- b) Certified Survey Map No 5157, Volume 35, Page 130, as Document No. 710693;
- c) That part of the East 33 feet of said Northeast Quarter of the Southwest Quarter and the Southeast Quarter of the Southwest Quarter as described in that Deed recorded as Document No 800765

**WHEREAS**, it is the recommendation of the Executive Committee that the Supervisory District Plan adopted by Resolutions 2011-15 and 2011-31, as amended by Resolutions 2013-41, 2013-42, 2014-45, 2018-25, 2019-3, 2019-21, 2020-4, 2020-5, and 2020-23 be amended to transfer the above-described parcel from Supervisory District 25 to 22; and

**WHEREAS**, this resolution was approved by the Executive Committee on December 2, 2020, on a vote of 9-0, with 9 voting in favor and no members voting against.





