

RESOLUTION NO.: 129—2021-22

TO THE HONORABLE, THE OUTAGAMIE COUNTY BOARD OF SUPERVISORS

LADIES AND GENTLEMEN:

MAJORITY

1 By adoption of Resolution 67—2021-2022, the Outagamie County Board approved a
2 tentative county supervisory district plan pursuant to the requirements of 59.10(3)(b),
3 Wisconsin State Statutes. This plan provides thirty-six (36) County Supervisory Districts.
4 The County Board held a public hearing to permit the general public and municipalities
5 within Outagamie County to express their views concerning the apportionment of
6 Supervisory Districts in Outagamie County. The Redistricting Oversight Committee met
7 several times to review and endorse supervisory district changes that were required to
8 address municipal ward plan needs related to issues such as statutory criteria for wards,
9 communities of interest, preservation of political subdivisions, and election administration
10 considerations. Additionally, the Redistricting Oversight Committee has considered all
11 aspects and written and verbal testimony as it relates to apportionment and creation of
12 Supervisory Districts in Outagamie County in accordance with the 2020 Federal Decennial
13 Census and requirements of Wisconsin and Federal law.

15 NOW THEREFORE, the following resolution is presented by the Legislative/Audit and Human
16 Resources Committee to the County Board.



17 BE IT RESOLVED, that the Outagamie County Board of Supervisors does approve and adopt the
18 Final County Supervisory District Plan for Outagamie County apportioned into thirty-six (36) supervisory
19 districts as noted on the attached Final Supervisory District Plan, which by reference is made a part hereof
20 and is also available in the Office of the Outagamie County Clerk, and

21 BE IT FINALLY RESOLVED, that the Outagamie County Clerk, according to the requirements
22 of both the state and federal redistricting rules, be directed to forward a certified copy of this resolution,
23 along with the Final Supervisory District Plan developed by the Outagamie County Development and
24 Land Services Department that represents the apportionment into thirty-six (36) supervisory districts, to
25 the governing body of each township, city, and village, wholly or partially contained in Outagamie County
26 and to the Outagamie County Board Chairperson who shall file a certified copy of this resolution with the
27 Wisconsin Secretary of State.

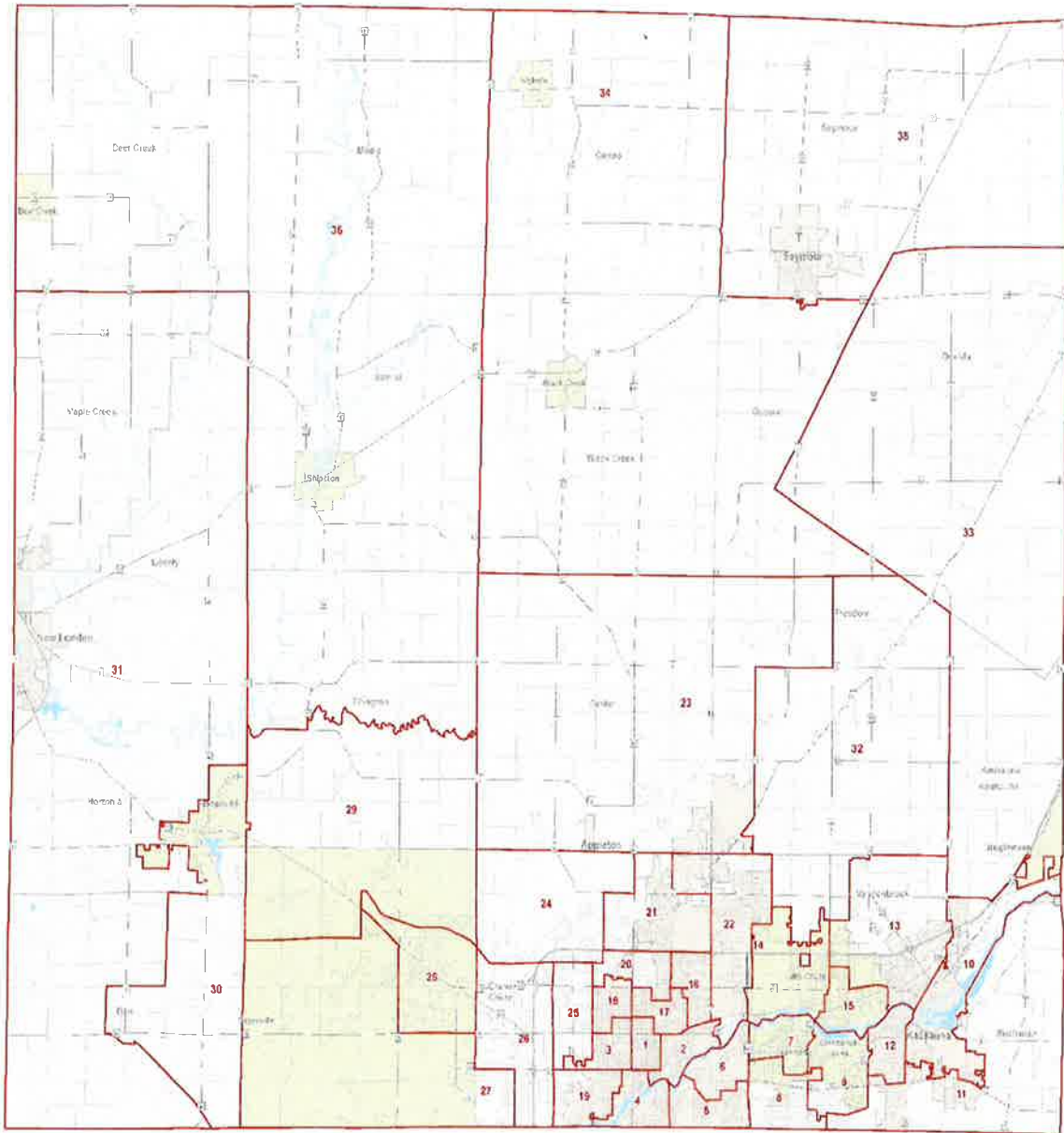
