Supervisory District 1 has a total of 1,017 people and is made up of Ward 1 Town of New Haven (680 people) and Ward 2 Town of Jackson (337 people).

Supervisory District 2 has a total of 1,059 people and is made up of Ward 1 Town of Springville (421 people) and Ward 2 Town of Dell Prairie (638 people).

Supervisory District 3 has a total of 1,098 people and is made up of Ward 1 Town of Dell Prairie (993 people), Ward 5 City of Wisconsin Dells (86 people) and Ward 9 City of Wisconsin Dells (19 people).

Supervisory District 4 has a total of 1,008 people and is made up of Ward 1 Town of Jackson (804 people) and Ward 3 Town of New Chester (204 people).

Supervisory District 5 has a total of 1,025 people and is made up of Ward 2 Town of Springville (862 people) and Ward 2 Town of Quincy (163 people).

Supervisory District 15 has a total of 1,046 people and is made up of Ward 1 Town of Preston (1,046 people).


Supervisory District 16 has a total of 1,015 people and is made up of Ward 1 Town of Strongs Prairie (1,015 people).




Supervisory District 18 has a total of 945 people and is made up of Ward 2 Town of Rome (945 people).


Supervisory District 19 has a total of 1,115 people and is made up of Ward 3 Town of Rome (579 people) and Ward 4 Town of Rome (536 people).


