CHAPTER 8 COUNTY SUPERVISORY DISTRICTS –
SECTION 8.01 (5) Descriptions of Districts**

The Marinette County Board of Supervisors does ordain as follows:

Section One: Section 8.01 (5) County Supervisory Districts is hereby repealed and recreated as follows:

8.01 COUNTY SUPERVISORY DISTRICTS

(5) Description of Districts:

Supervisory District 1 (Population 1380)

That part of the City of Niagara described as:

Commencing at the intersection Main St/USH 141 and Hill St; thence southerly along Hill St to Forest St, easterly along Forest St to Brook St; thence southerly along Brook St to Ridge St, east along Ridge St to Meridian St; thence south along Meridian St to Park St, east and south along Park St extended to south city line; thence easterly, southerly and northerly along south city line to the thread of the Menominee River; thence meandering westerly, northerly and easterly along the thread of the Menominee River and the city limits to the northwest corner of the City of Niagara; thence southerly and easterly along the city limits to the place of beginning.

Supervisory District 2 (Population 1366)

The Town of Niagara and part of the City of Niagara and the Town of Pembine described as follows:

City of Niagara

Commencing at the intersection of Main St/USH 141 and Hill St; thence southerly along Hill St to Forest St, easterly along Forest St to Brook St; thence southerly along Brook St to Ridge St, east along Ridge St to Meridian St; thence south along Meridian St to Park St, east and south along Park St extended to south city line; thence west along south city line to intersection southwest corner of city and Saler Rd, north, west and north along west city line to Main St/CTH N, easterly along Main St to 4th St; thence south along 4th St to Vine St, easterly along Vine St to Main St/USH 141, southeast along Main St/USH 141 to Hill St and place of beginning.

10 line of Town of Dunbar and north line Town of Athelstane; thence continue south along east line

45 west along north lines of Towns of Athelstane and Silver Cliff and place of beginning.

7 southeast and easterly along Perch Lake Rd to point on the west boundary of the Village of
8 Wausaukee; thence northwesterly, east and south along the Village limits to State Highway 180;
9 thence easterly along State Highway 180 to Mud Lake Rd; thence north, east and south on Mud
10 Lake Rd to McCall Creek; thence northeasterly along McCall Creek to Menominee River; thence
11 northerly along the Menominee River to Amberg's north town line; thence west along the north
12 line of Amberg to the place of beginning.

23 on Johnson Falls Rd to an overhead transmission line; thence north along the transmission line to
24 the Peshtigo River; thence easterly along Peshtigo River to intersection with High Falls Rd;
25 thence east along High Falls Rd to Newton Lake Rd; thence north along Newton Lake Rd to
26 County Road X; thence west on County Road X to Deer Lake Rd; thence northerly and westerly
27 along Deer Lake Rd to Boat Landing 7 Rd; thence westerly along Boat Landing 7 Rd to point of
28 north-south ¼ line of Section 18, T33N, R19E; thence north on north-south ¼ line of Section 18,
29 T33N, R19E to its intersection with Eagle Rd; thence westerly along Eagle Rd to Evans Hill Rd;
30 thence northerly along Evans Hill Rd to Lager Lane; thence north along Lager Lane to the place
31 of beginning.

43 thence north on Newton Lake Rd to County Road X; thence east on County Road X to east line
44 of T33N, R19E; thence south on said line to southwest corner of T33N, R20E; thence east along
45 the north line of T32N, R20E to the northeast corner of T32N, R20E; thence south along east
46 line of T32N, R20E to the thread of the Peshtigo River; thence southwesterly to County Road

1 W; thence along County Road W to Old W Rd; thence northwesterly along Old W Rd to the east
2 limits of the Village of Crivitz; thence north and east along village limits to most northeast
3 corner in the Village; thence west on north Village line to most northwest corner in the Village;
4 thence southerly and easterly along the village limits to US Highway 141; thence south on US
5 Highway 141 to intersection with south line Town of Stephenson; thence west along south line
6 Stephenson to intersection of 37th Rd and Williston Springs Rd; thence west along Williston


