3 4 5	WHEREAS, at their meeting of July 14, 2020, the Walworth County Board did approve Resolution No. 23 – 07/20 Requesting the Southeastern Wisconsin Regional Planning Commission (SEWRPC) Prepare a Redistricting Plan for Walworth County Following the 2020
6 7	United States Census; and,
8	WHEREAS, on December 8, 2020, the Walworth County Board of Supervisors adopted
9	Resolution No. 58-12/20 Establishing Criteria and Guidelines to be Used in Developing a
10	Redistricting Plan; and,
11 12	WHEREAS, the release of the United States Census data that was required to perform the
13	redistricting was delayed from March of 2021 to August of 2021, requiring counties and
14 15	municipalities to expedite their redistricting activities to ensure that new district information was available to potential candidates to circulate nomination papers; and,

17 18	WHEREAS, the proposed Tentative Supervisory District Plan for Walworth County-2021 developed by SEWRPC was delivered to County Board Supervisors for review; and,
19 20	WHEREAS, a public hearing on the Tentative Supervisory District Plan for Walworth County -
20 21 22	2021 was conducted on September 14, 2021 at 3:30 PM; and,
22	WHEREAS, on September 14, 2021, the Walworth County Board of Supervisors adopted the
24 25	Tentative Supervisory District Plan for Walworth County-2021 as developed by SEWRPC; and,
26 27 28 29	WHEREAS, pursuant to the direction given by the County Board, the Walworth County Clerk transmitted this plan to each municipal governing body within Walworth County in accordance with the provisions of Section 59.10(3)(b)1 of the Wisconsin Statutes; and,
29 30	WHEREAS, Section 59.10(3) (b) of the Wisconsin Statutes requires County Boards to hold a
31 32	public hearing and adopt a final supervisory district plan; and,
33	WHEREAS, a public hearing on the Final Supervisory District Plan for Walworth County-2021
34	was conducted today, November 9, 2021 at 3:30 PM; and,

36	WHEREAS, a number of minor modifications were proposed and incorporated into the Final
37 38	Supervisory District Plan for Walworth County-2021 which were fully vetted and discussed by the Walworth County Board of Supervisors at the public hearing on November 9 th .


- I. Title: Adopting the Final Supervisory District Plan for Walworth County-2021
