UPDATE ON SALE OF COUNTY OWNED PROPERTY

Conwed Building – 800 Gustafson Rd. Ladysmith, WI 54848

Rich Summerfield and Andy Albarado presented the sale of Conwed Building Purchased by Henry Gun in July 2021. Rusk County purchased the building originally in 2016 for \$1.65 million and sold the building for \$1.75 million for a profit of approx. \$390,000.00. Henry Gun has started moving in machining equipment and is planned to officially start soon as hiring has begun for the Ladysmith location.

BUDGET

<u>Update 2022 Budget – Kitzie Winters presenting</u>

No changes to the budget since it was previously presented. Mill rate is down .05%; from 7.16 per 1000 Assessed Valuation to 6.79 per 1000 Assessed Valuation. Currently 750,000 in the contingency fund; 8.6 million in general fund.


